About this Reference Group



A **Reference Group** is a group of people who give us advice about a certain topic.

This Reference Group is about:



children



young people



• their families.



The Reference Group shares their ideas with the IAC about how to support children and young people with disability.

This includes support to:



do things for themselves



• take part in the community.



The IAC use these ideas from the Reference Group when they write their advice for the National Disability Insurance Agency (NDIA) Board.

We just call them the **NDIA Board**.



The NDIA Board is a group of people who make decisions about all parts of the NDIA.

What issues did the community share?



Reference Group members connected with the community to find out about issues that affect them.



This includes issues that affect participants.

Participants are people with disability who take part in the National Disability Insurance Scheme (NDIS).



Members shared reports about these issues with the NDIA.



People from the NDIA also shared their response to some of these issues.

Changes to NDIS laws



Reference Group members said people are worried about some changes to NDIS laws.



This includes laws about:

- NDIS supports
- NDIS plans.



An NDIS plan is a document that includes information about:

- a participant and their goals
- what support they receive from the NDIS
- what the NDIS will pay for.



This means participants can't get some supports from the NDIS anymore.



And it is hard for them to pay for these supports themselves.



Members said people are also confused about how **funding periods** have changed.



Funding periods tell participants:

- when part of their funding can be used
- how long their funding needs to last.



Funding is money from someone's NDIS plan that pays for the supports they need.



Some people didn't know that funding periods would change before they did.



People also are unsure if these funding periods are right for families with young children.

The NDIA said decisions about funding periods should:



• be made with the participant



• change to support what a participant needs.

Changes to NDIS plans

Reference Group members said people are worried about changes to:



• NDIS plans



 how the NDIA checks if a participant still needs NDIS supports.



Participants and their families are worried the NDIA are not listening to what they have to say.



They also want the NDIA to explain more clearly how they make decisions.



The NDIA said they're working with the community to improve their experiences.

Long wait times for early childhood supports



Reference Group members said some participants have to wait a long time for early childhood supports.



Members said this is causing a lot of issues for participants who need support.

The way the NDIA communicates



Reference Group members said the NDIA should improve the way they communicate.



The NDIA said they know it's important to improve how they communicate about changes to the NDIS.

This includes how the NDIA shares this information with:



• their staff



• the IAC and Reference Groups



• the disability community.

Update on the NDIA's Children's Taskforce



The NDIA gave an update about their work on their Children's Taskforce.



The Children's Taskforce focuses on children up to **14 years old** who take part in the NDIS.



It supports these children during different stages of their life.



The NDIA said they are working on a new way for children **younger than 9 years old** to get support:

- as early as possible
- when they first get a disability.

The NDIA are working on:



 making a group where young people can share what they have to say



 meeting with First Nations parents who have children with disability.



The NDIA are also working on how they check if young children still need the NDIS when they are **over 6 years old**.



They want to make sure more children **between 0 to 8 years old** get the support they need.



Reference Gorup members said they were happy the NDIA gave them an update on this work.

Update on the IAC Work Plan



A Work Plan is a document that explains the work the IAC will do from:

• 1 July 2025

to

• 30 June 2026.



The IAC's Independent Advisor gave an update on the **draft** IAC Work Plan.

A draft is a document that isn't finished yet.



The IAC's Independent Advisors are people who work with the IAC and Reference Groups.

They help the IAC and Reference Groups make their advice.



They told Reference Group members how their skills can support the Work Plan.



Members talked about what they would like to include in a smaller Work Plan.


