## What happened at the meeting?



Ms Sylvana Mahmic ran the meeting.

She is an IAC Member.



We held the meeting on 15 April 2024.



Sylvana welcomed members from the National Disability Insurance Agency (NDIA) Board.

We just call them the **NDIA Board**.

The NDIA Board is a group of people who make decisions about all parts of the NDIA.



Sylvana also welcomed some people who help run the NDIA.

## Our reports



The IAC Members connected with the community to find out about issues that affect them.

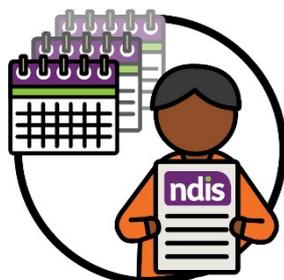


The IAC Members shared these issues with the NDIA.

## What did the reports talk about?



**Participants** are people with disability who take part in the NDIS.



IAC Members shared that some participants have to wait longer to get their **NDIS plans**.



Your NDIS plan is a document that has information about:

- you and your goals
- what supports you need.



IAC Members also shared that there are issues with the way people get some supports.



For example:

- home and living supports
- supports for children and young people.



IAC Members explained that it's important that the NDIS:

- is fair to children and young people
- gives children and young people the same chances as other people.



IAC Members also explained that some community run disability services are facing issues.

These issues affect their participants.



For example:

- it can be hard for them to find staff
- they might have to close.



These disability services use money from the government to pay for their supports.

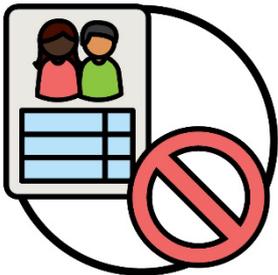


For example, they might get money from the **Information, Linkages and Capacity Building program.**

We call it the ILC program.



The ILC program gives grants to organisations that support people with disability.



Some programs that use ILC grants are ending. This will affect community run disability services.



IAC Members shared that it's important for the NDIA to share **accessible** information with the community.



When information is accessible, it is easy to:

- find and use
- understand.

Sharing accessible information would help the community understand:



- how laws about the NDIS will change



- what NDIA **co-design** is.

Co-design is when people work together to plan something new.



IAC Members shared they have seen news about some NDIS **providers** who treat participants badly.

Providers support people with disability by delivering a service.



IAC Members shared that people with disability need ways to:

- stay safe
- get the support they need.

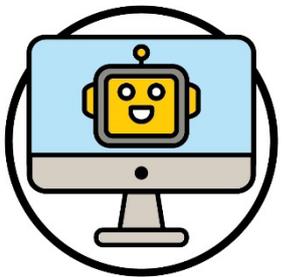


The news also says that there are issues with NDIS supports for people with disability in the **justice system**.

The justice system includes:



- prisons
- the courts
- police
- the law.



IAC Members explained that **artificial intelligence** might make the NDIS better.

We just call it AI.



AI technology can:

- solve problems
- help the NDIS make decisions.

## Changing the laws about the NDIS



IAC Members and people from the NDIA talked about the Australian Government's plans to change laws about the NDIS.



IAC Members worry about the Government making new rules for who can take part in the NDIS.



IAC Members also worry about the way the law explains what can be an NDIS support.



This could change what supports people can use **funding** for.

Funding is money from the government that pays for services and supports.



IAC Members thanked the NDIA for explaining how the law could change.

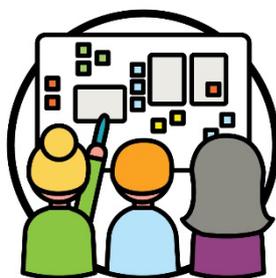
IAC Members explained that the NDIA should:



- share more accessible information about the laws with the community



- explain to the community how changing the law will affect them



- explain how they use co-design to make new rules and plans.

## NDIA's co-design plan



The NDIA made a plan to change how they do co-design.

They want to make sure they use co-design the way the community wants them to.



IAC Members explained that the NDIA has already done some good co-design work.

They can use that work to improve their co-design in the future.



IAC Members told the NDIA that they should use co-design to check how well services work.

They should do this when they plan something new.

IAC Members explained that the NDIA should try to do co-design with lots of different people.



This includes people with different:

- ages
- abilities
- backgrounds
- beliefs.



IAC Members told the NDIA they should make sure they plan enough time to do co-design work the right way.

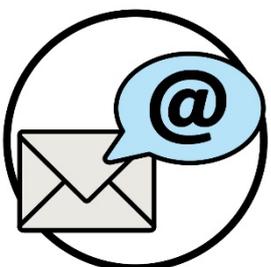

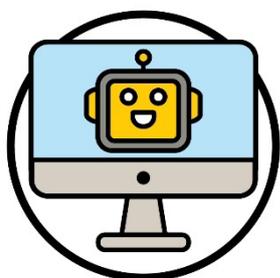

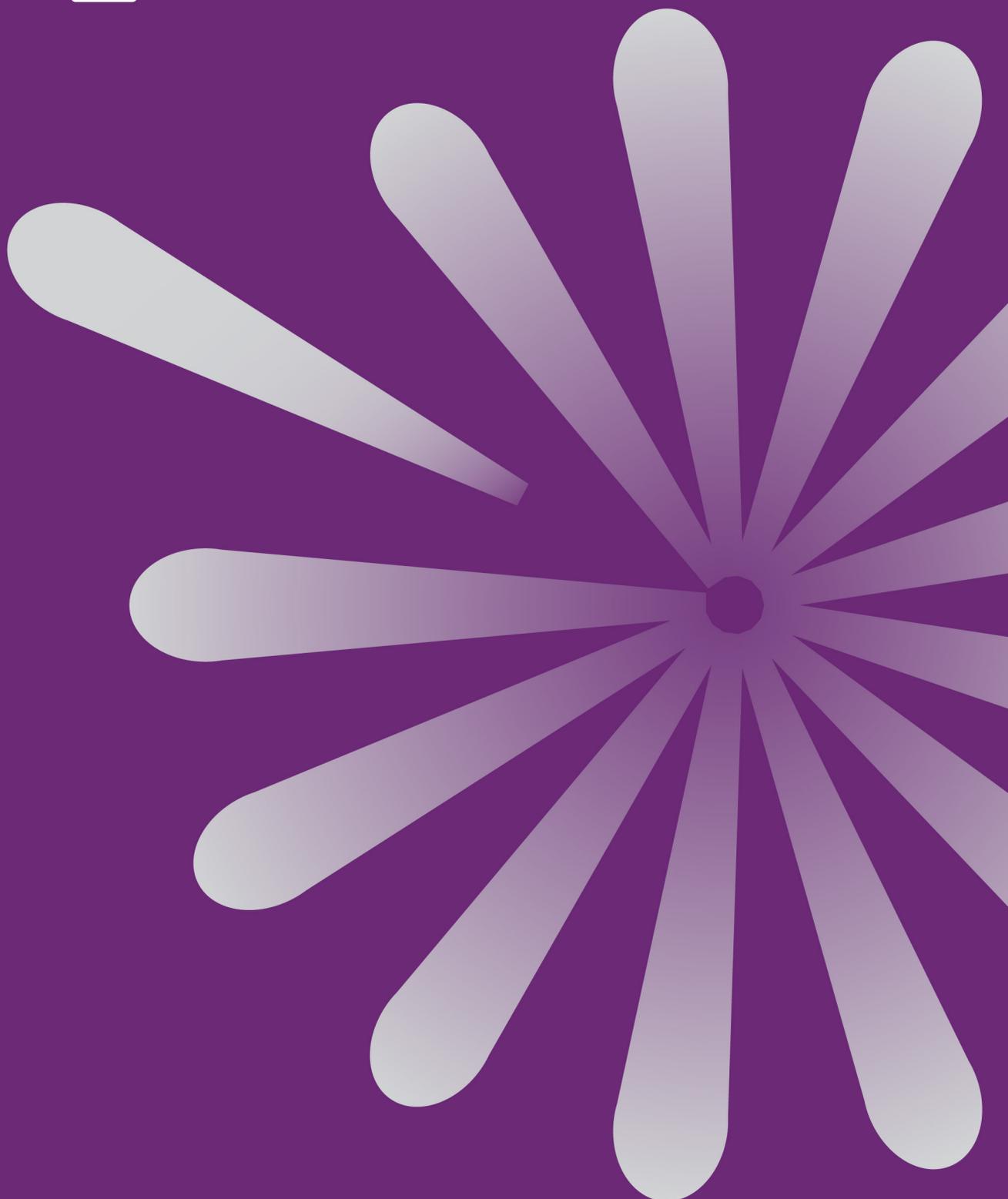
